

**EXTENSION OF THE TRANSITION PERIOD FOR THE  
ELIMINATION OF TRADE-RELATED INVESTMENT MEASURES NOTIFIED UNDER  
ARTICLE 5.1 OF THE AGREEMENT ON TRADE-RELATED INVESTMENT MEASURES**

**PAKISTAN**

*Draft Decision*

The Council for Trade in Goods,

*Having regard* to the decision of the Council for Trade in Goods of 31 July 2001 (G/L/466);

*Noting* that Pakistan has committed itself to eliminate its remaining TRIMs;

*Taking note* that Pakistan has submitted a request for a further extension of the transition period until 31 December 2003 for the elimination of the remaining TRIMs it notified under Article 5.1 of the TRIMs Agreement, accompanied by a description of the steps Pakistan has taken to date and/or will take to eliminate its remaining TRIMs; a reasonable phase-out plan for eliminating its remaining TRIMs no later than 31 December 2003, taking into account its development, financial and trade needs; and a commitment to submit periodic reports to the Council for Trade in Goods on the progress it makes in phasing out its remaining TRIMs (G/C/W/294);

*Decides* as follows:

1. The transition period is extended for Pakistan until 31 December 2003 for the TRIMs for which an additional extension of the transition period has been requested subject to Pakistan meeting the agreed terms of its phase-out plan.
2. Pakistan shall report by 31 December 2002 to the Council for Trade in Goods on the progress it makes in phasing out its remaining TRIMs.
