## NOTE FROM THE SECRETARIAT

In order to assist Members, the following are deadlines for submissions established by the Committees on Anti-Dumping Practices, Subsidies and Countervailing Measures, and Safeguards, and subsidiary bodies, at their meetings held on 25, 31, and 28 October 2002, respectively.

### A. AD/CVD LEGISLATION NOTIFICATIONS

The Secretariat will circulate to Members in mid-March 2003 a list of the **new notifications of legislation** that will be on the agenda for review at the regular meetings in May 2003. Pursuant to procedures adopted by the Committees, notifications circulated in all three WTO working languages not later than 20 March 2003 will be reviewed at the Committees' May 2003 regular meetings. Although a definitive list cannot be provided until after that date, the following notifications have already been received and are expected to be reviewed at that meeting:

## **B. SAFEGUARDS LEGISLATION NOTIFICATIONS**

The Secretariat will circulate to Members in mid-March 2003 a list of the **new notifications of legislation** that will be on the agenda for review at the regular meeting in April 2003. Pursuant to procedures adopted by the Safeguards Committee, notifications circulated in all three WTO working languages not later than 17 March 2003 will be reviewed at the Committee's April 2003 regular meeting.

9 June 2003	Written answers to questions regarding new notifications of legislation reviewed at the Committees' regular meetings in April 2003.
17 March 2003	Written questions regarding previously reviewed notifications of legislation, for consideration at the Committee's regular meeting in April 2003.
14 April 2003	Written answers to questions regarding previously reviewed notifications of legislation submitted by 17 March 2003, for consideration at the Committee's regular meeting in April 2003.
7 April 2003	Written questions regarding new notifications of legislation to be reviewed at the Committee's regular meeting in April 2003.

## **C. SUBSIDY NOTIFICATIONS**

The Secretariat will circulate to Members shortly after 23 December 2002, a list of **2001 new and full new subsidy notifications** that will be on the agenda for review at the Committee's special meeting scheduled for May 2003. Pursuant to the understanding reached at the 31 October 2002 meeting to apply the same procedures and deadlines adopted by the SCM Committee also to those 2001 new and full subsidy notifications received following the October 2002 meeting, such notifications circulated in all three WTO working languages not later than 23 December 2002 will be reviewed at the May 2003 meeting. Members will recall that the **2003 new and full subsidy notifications are due by 30 June 2003**, and that the Committee will address timing and procedures for review of such notifications at the May 2003 meeting.
