#### Addendum

#### *Overview of the State of Play of WTO Disputes*

The attached overview, which reflects the state of play of WTO disputes from **1 January 1995 to 31 October 2003**, has been prepared by the Secretariat on its own responsibility. Section I summarizes the developments from the initial requests for consultations until the establishment of panels, including the cases where mutually agreed solutions were found. Section II deals with the stages covering the establishment of panels, circulation of panel reports, appeals and reports of the Appellate Body and finally the adoption of the reports. Section III covers the stage dealing with the monitoring of the implementation of the DSB's recommendations. Finally, Section IV(i) and (ii) covers recourse to Articles 21.5 and 22 of the DSU, respectively.
