Description of content: This regulation establishes tolerances for combined residues of trifloxystrobin in or on leaf petioles subgroup 4B; and vegetable, root, except sugar beet, subgroup 1B, except radish. Interregional Research Project Number 4 (IR-4) requested these tolerances under the Federal Food, Drug, and Cosmetic Act (FFDCA), as amended by the Food Quality Protection Act of 1996 (FQPA). The tolerances are established for combined residues of trifloxystrobin, (benzeneacetic acid, (E,E)-[alpha]-(methoxyimino)-2-[[[1-[3-(trifluoromethyl) phenyl]ethylidene]amino]oxy]methyl]-, methyl ester) and the free form of its acid metabolite CGA-321113((E,E)-methoxyimino-[2-[1-(3-trifluoromethyl phenyl) ethylideneaminooxymethyl] phenyl]acetic acid) in or on leaf petioles subgroup 4B at 3.5 ppm, and vegetable, root, except sugar beet, subgroup 1B, except radish at 0.10 ppm.
