6.	<p>Description of content: This draft Standard prescribes the minimum requirements for the type approval of radio communications non-multiplex equipment operating in either frequency of pulse modulation mode for use in the fixed/land mobile/personal radio service for official and private correspondence in the allocated VHF/UHF bands in the frequency range of 30 MHz to 866 MHz.</p> <p>It also describes the minimum requirement only for a particular type of equipment. Certain users may wish to specify other requirements to meet specific applications using the type of equipment, however, this shall not be done at the expense of derogating performance below the minimum requirements contained herein.</p> <p>Tests according to this draft Standard are type approval performance tests and do not include the electrical or mechanical safety of the equipment.</p>
7.	Objective and rationale: Ensures that radio communications equipment for use in the fixed/land mobile/personal radio services are acceptable for licensing in the Philippines and will not cause harmful radio interface to existing stations.
