STATISTICS FOR 2000 REPORTED UNDER ARTICLE XIX:5 OF THE AGREEMENT

The following communication contains the Norwegian statistical report on public procurement for 2000. The report shows the value of public contracts subdivided by type (supplies, works or services) and by procedure (open, restricted and negotiated). There are also indications on nationality of the suppliers and products. A listing by CPV numbers on a two-digit level is also included in the statistical report presented. The statistical material is based on information from TED (Tenders Electronic Daily) where 339 contract awards with a total value of NOK 8005 million were found. The statistical material indicates that about 5 percent of the contracts were awarded to foreign suppliers. The actual figure is, however, higher because of the number of Norwegian suppliers that are subsidiaries of foreign companies, or agents for foreign companies is unknown.

I. BACKGROUND

This Statistical Report on Public Procurement under the General Procurement Agreement (GPA) includes the number and value of contracts awarded by each contracting authority above threshold in 2000, divided into two groups: classical sector and utility sector. The classical sector includes procuring entities listed in Annex 1 and 2 in the GPA. The utility sector includes procuring entities in Annex 3 to the GPA.

The report is divided by CPV codes and type of procurement (supplies, services and works). Each type of procurement is further subdivided by procedure and with indication of product and nationality of the supplier to whom the contract was awarded as far as the source material permits.

II. METHOD

Contracting authorities that have awarded a contract above thresholds, shall make results known by means of a notice published in the Official Journal of the European Commission and in the Tenders Electronics Daily (TED) database. In order to present all contracts awarded in Norway in 2000, a printout from TED 2000 was made. All contracts awarded in 2000 were divided as follows:

1. Total

This statistical report covers 339 contract awards with total value of NOK 8004 million.

Of the 333 contract awards there were :

- 155 supply contracts, with total contract value of NOK 4731 million
- 82 service contracts, with total contract value of NOK 1492 million
- 36 works contracts, with total contract value of NOK 8845 million

- 66 utilities contracts, with total contract value of NOK 898 million.

2. Supply contracts (Annex 1)

The 155 supplies contract awards given by 63 contracting authorities had a **total value of NOK 4731 million**. Approximately 5 per cent of the contracts were awarded directly to foreign suppliers. The foreign suppliers are mainly located in Northern Europe.

Of the supply contracts, 143 contracts were awarded by open procedure, accounting for 92 per cent of the value of supply contracts; 9 contracts were awarded by restricted procedure, accounting for 5 per cent of the value of supply contracts; and 3 contracts were awarded by negotiated procedure, accounting for 3 per cent of the value of supply contracts.

3. Service contracts (Annex 2)

A total of 47 contracting authorities awarded 82 service contracts with a **total value of NOK 1492 million**. 2 contracts were awarded directly to foreign suppliers from France and the UK. The rest were awarded to suppliers with postal address within Norway. Of the 82 contracts 51 contracts were awarded by open procedure, representing 66 per cent of total value of service contracts; 9 contracts were awarded through restricted procedure, accounting for 8 per cent of the value of service contracts; 23 contracts were awarded through negotiated procedure; accounting for 26 per cent of the value of service contracts.

4. Works contracts (Annex 3)

A total of 16 contracting authorities awarded 85 works contracts with a **total value of NOK 884 million**. The contracts were awarded to suppliers with postal address within Norway, and two contracts to Denmark and the UK, respectively. Of the 34 contracts 32 were awarded by open procedure, representing 94 per cent of total value of works contracts; 2 contracts were awarded through negotiated procedure; accounting for 6 per cent of the value of works contracts.

5. Utility contracts (Annexes 5 and 6)

The 66 utility contract awards published in TED were awarded by 29 contracting authorities, and have a **total value of NOK 898 million**. Ten contracts were awarded using open procedure and accounts for 15 per cent of the total number. Restricted procedure was used in 2 cases, consisting of 3 per cent of the total value, and 55 contracts were awarded using the negotiated procedure, representing 83 per cent of the total value of the contracts awarded.

III. COMMENTS

1. Supplier nationality

Many contract awards have more than one supplier, and some of the contracts have more than one nationality of suppliers. In the statistics all nationalities have been noted regardless of how large a part they were awarded respectively.

Only a small percentage of the contracts in the classical sector were awarded to suppliers with foreign postal address. This figure is, however, somewhat misleading considering the number of Norwegian suppliers who are subsidiaries of foreign companies or agents for foreign suppliers.

2. Public works contracts under threshold

Many of the public works contracts published in TED are below the thresholds as they are part of a larger project. There is usually no indication in the notice in TED, as to which main project these contract awards belong to, or whether the subcontract is included in the main project or not.

3. Prices and estimated value

All prices are given in Norwegian kroner (NOK), excluding Value Added Tax).

Some contract awards do not state the price. Contracting authorities in the utilities sector are not obliged to state the contract value in post contract award notices. Contracting authorities in the classical sector may postpone publishing the contract value to guard commercial interests.

4. Listing of contracts by CPV number

Of the contracts awarded in the by the classical sector, all contracts were not assigned to a CPV number. Thus, the summing of contracts in Annex 4 will not add up completely with the total number of contracts reported in Annexes 1 to 3.
