NOTIFICATION UNDER PARAGRAPH 9 OF THE UNDERSTANDING ON THE BALANCE-OF-PAYMENTS PROVISIONS OF THE GENERAL AGREEMENT ON TARIFFS AND TRADE 1994

Communication from Pakistan

The following communication, dated 6 November 1998, has been received from the Permanent Mission of Pakistan.

In accordance with the decision taken by the Committee on Balance-of-Payments Restrictions during its resumed consultations with Pakistan held on 10 November 1997, the government of Pakistan presents the attached phase-out schedule for its quantitative restrictions being maintained under Article XVIII:B of the GATT 1994.
