UNIÓN ADUANERA ENTRE TURQUÍA Y LA COMUNIDAD EUROPEA

Comunicación de las Partes en la Unión Aduanera

Turquía y las Comunidades Europeas tienen el honor de referirse a la notificación sobre un modelo normalizado para la Unión Aduanera entre las dos Partes, presentada al Presidente del Comité de Acuerdos Comerciales Regionales (WT/REG22/5), y en concreto a las "Disposiciones por sectores específicos" de la sección 8 relativas al sector de los textiles y el vestido.

Turquía y las Comunidades Europeas, con el fin de prestar asistencia a los Miembros en el examen de la unión aduanera, se complacen en confirmar, en el anexo adjunto¹, pormenores de las limitaciones cuantitativas que Turquía aplica a las importaciones de determinados productos del sector de los textiles y el vestido procedentes de algunos Miembros de la OMC, de conformidad con lo dispuesto en el artículo XXIV del GATT de 1994.
