NOTE FROM THE SECRETARIAT

In order to assist Members, the following are deadlines for submissions established by the Committees on Anti-Dumping Practices, Subsidies and Countervailing Measures, and Safeguards, and subsidiary bodies, at their meetings held on 1-5 May, 9-xx May, and 8 May, respectively.

A. AD/CVD LEGISLATION NOTIFICATIONS

The Secretariat will circulate to Members in mid-September 2000 a list of the **new notifications of legislation** that will be on the agenda for review at the regular meetings in November 2000. Pursuant to procedures adopted by the Committees, notifications circulated in all three WTO working languages not later than 21 September will be reviewed at the Committees' November 2000 regular meetings. Although a definitive list cannot be provided until that date, the following notifications have already been received and are expected to be reviewed at that meeting: **Chile**, G/ADP/N/1/CHL/2, and **Turkey**, G/ADP/N/1/TUR/3.

10 July 2000	Written answers to questions regarding new notifications of legislation reviewed at the Committees' regular meetings of 4-5 May and xxx May 2000.
21 September 2000	Written questions regarding previously reviewed notifications of legislation, for consideration at the Committees' regular meetings in November 2000.
19 October 2000	Written answers to questions regarding previously reviewed notifications of legislation submitted by 21 September 2000, for consideration at the Committees' regular meetings in November 2000.
12 October 2000	Written questions regarding new notifications of legislation to be reviewed at the Committees' regular meetings in November 2000.

B. SAFEGUARDS LEGISLATION NOTIFICATIONS

The Secretariat will circulate to Members in mid-September 2000 a list of the **new notifications of legislation** that will be on the agenda for review at the regular meeting on 9 November 2000. Pursuant to procedures adopted by the Safeguards Committee, notifications circulated in all three WTO working languages not later than 28 September 2000 will be reviewed at the Committee's November 2000 regular meeting.

28 September 2000	Written questions regarding previously reviewed notifications of legislation, for consideration at the Committee's regular meeting on 9 November 2000.
26 October 2000	Written answers to questions regarding previously reviewed notifications of legislation submitted by 28 September 2000, for consideration at the Committee's regular meeting on 9 November 2000.
19 October 2000	Written questions regarding new notifications of legislation to be reviewed at the Committee's regular meeting on 9 November 2000.

C. SUBSIDY NOTIFICATIONS (WILL THERE BE A SPECIAL MEETING?)

The Secretariat will circulate to Members shortly after 26 June 2000, a list of **1998 new and full new subsidy notifications** that will be on the agenda for review at the Committee's meeting in the week of 6 November 2000. Pursuant to procedures adopted by the SCM Committee, such notifications circulated in all three WTO working languages not later than 26 June 2000 will be reviewed at that meeting. Although a definitive list cannot be provided until that date, the following notification has already been circulated and thus will be reviewed at that meeting: Cyprus.¹
