

**INTRODUCTION OF HARMONIZED SYSTEM 1996 CHANGES
INTO WTO SCHEDULES OF TARIFF CONCESSIONS**

VENEZUELA – SCHEDULE LXXXVI

Request for Waiver

The following communication, dated 19 February 2002, has been received from the Permanent Mission of Venezuela.

I have the honour to submit a request for a waiver from the obligations undertaken by Venezuela under Article II of the GATT 1994, for a period of six months.

This request is being made pursuant to the provisions of paragraph 3 of Article IX of the WTO Agreement, taking account of the reservations raised by the European Communities regarding the Schedule LXXXVI proposed by Venezuela, as a result of which the consultation and negotiation procedures referred to in Article XXVIII of the GATT 1994 cannot be completed on time.

In accordance with the decision reached at the meeting of the Committee on Market Access on 18 February 2002, the requested factual information and the draft waiver decision are annexed hereto.

Status of outstanding Article XXVIII negotiations as well as a general outline of relevant problems, if any:

The European Communities have raised concerns in connection with six tariff headings that were affected by the changeover to the 1996 Harmonized System. To date, the questions pertaining to five out of six of these headings have been dealt with, and only the concerns relating to one heading remain to be solved.

Outlook for concluding the process:

Venezuela expects to be able to conclude the negotiating process before the period of time specified in the request has elapsed.
