3. Meetings of the Committee on Rules of Origin

3.1 The Committee on Rules of Origin (CRO) has held three formal meetings on 19 April, 28 June and 15 November 2002. The minutes of these meetings are contained in documents G/RO/M/40-42.

3.2 With regard to *the work under Part II* of the Agreement on Rules of Origin (the Agreement), the CRO, at its meeting in November 2002, carried out the transitional review under paragraph 18 of the Protocol of Accession of the People's Republic of China.

3.3 With regard to *the work under Part III* of the Agreement, the CRO, at each meeting, took note of the notifications under Article 5 and paragraph 4 of Annex II of the Agreement. To date 83 Members have made notifications of non-preferential rules of origin and 87 Members have made notifications of preferential rules of origin (see Annex). The Chairman expressed concern that a number of Members had not yet complied with the notification requirements. He urged Members who had not yet notified to do so as early as possible (G/RO/M/40-42);

3.4 Apart from the above-summarized implementation and operation of *Parts II and III* of the Agreement, most of the CRO's formal and informal sessions were devoted to its *work under Part IV*, namely the Harmonization Work Programme (HWP). The Chairman of the Committee made a report to the General Council on the progress of the HWP at its meeting on 31 July 2002, and the CRO, as mandated, forwarded 93 core policy issues as well as the implications issue to the General Council for discussion and decision at that level (G/RO/52; WT/GC/M/75).

4. Annual Report to the Council for Trade in Goods

The CRO adopted its report to the CTG at its meeting on 15 November 2002 (G/L/593).
