6.	<p>Description of content: The Pest Management Regulatory Agency (PMRA), of Health Canada, has recently approved applications to amend the registration of quizalofop-ethyl in order to allow its use for the control of annual grasses on adzuki beans, black beans, brown and yellow eye beans, cranberry beans, lima beans, mung beans, navy beans, pinto beans, white beans and white and red kidney beans as a post-emergent treatment. The PMRA has also been requested to establish a Maximum Residue Limit (MRL) for residues of quizalofop-ethyl and its metabolites resulting from this use in adzuki beans, dry beans (which includes black beans, brown and yellow eye beans, cranberry beans and white beans), dry lima beans, kidney beans, mung beans, navy beans and pinto beans, in order to permit the sale of food containing these residues.</p> <p>After the review of all available data, the PMRA has determined that an MRL for quizalofop-ethyl, including its metabolites, of 0.15 p.p.m. in adzuki beans, dry beans, dry lima beans, kidney beans, mung beans, navy beans and pinto beans would not pose an unacceptable health risk to the public.</p> <p>As a means to improve the responsiveness of the regulatory system, an Interim Marketing Authorization (IMA) is being issued to permit the immediate sale of adzuki beans, dry beans, dry lima beans, kidney beans, mung beans, navy beans and pinto beans with an MRL for quizalofop-ethyl, including its metabolites, of 0.15 p.p.m., while the regulatory process is undertaken to formally amend the Regulations. A revision to this notification will be published at the start of the amendment process and Members will be given the opportunity at that time to submit comments on this proposed measure.</p>
