Description of content: As it was deemed necessary to revise the provisions on other milk products, the Ministry of Public Health is authorized to notify the public that: (i) The Ministry of Public Health Notification No. 36 (1979) was repealed; (ii) Other milk products are classified as specific-controlled foods; (iii) Heat treatments, storage and shelf life requirements, standards and qualities for each particular product are also provided for; (iv) Provisions on food packaging, food additives, food colour, production methods, equipment and storage and food labelling must comply with the relevant ministerial notification; (v) Those who acquired the approval for registered food recipes and labelling prior to this measure being in effect must apply for corrections in compliance with the provisions under this notification within 180 days after it comes into force.
