Good Manufacturing Practice shall be applied for production of certain sauces. In addition, this ministerial notification prescribes the following items:</p> <ul style="list-style-type: none">(1) Classification of sauces pursuant to this ministerial notification<ul style="list-style-type: none">- Chili sauce- Tomato sauce- Papaya sauce- Starch sauce or colour-added starch sauce- Mixed sauce(2) Quality or standards, i.e. odour, flavour, acidity, total solid content, bacteria, <i>Escherichia coli</i>, yeast and mould, free from toxic microorganisms, toxin from microorganisms in the content which may be harmful to health.(3) Containers(4) Labelling <p>Licences for food registration or food labelling issued prior to the enforcement of this ministerial notification will be valid for 2 years.</p> <p>Producers or importers who received licences prior to the enforcement of this ministerial notification must apply for licences within one year after this ministerial notification comes into force. Upon submitting the application, the former labels can still be valid for 2 years.</p>
