NOTE FROM THE SECRETARIAT

In order to assist Members, the following are deadlines for submissions established by the Committees on Anti-Dumping Practices, Subsidies and Countervailing Measures, and Safeguards, and subsidiary bodies, at their meetings held on 22-23 April, 29-30 April, and 19 April, respectively.

A. AD/CVD LEGISLATION NOTIFICATIONS

The Secretariat will circulate to Members in mid-September 2004 a list of the **new notifications of legislation** that will be on the agenda for review at the regular meetings in October-November 2004. Pursuant to procedures adopted by the Committees, notifications circulated in all three WTO working languages not later than 16 September 2004 will be reviewed at the Committees' October 2004 regular meetings.

13 May 2004	Written follow-up questions regarding new notifications of legislation reviewed at the Committees' regular meetings in April 2004.
1 July 2004	Written answers to questions regarding new notifications of legislation reviewed at the Committees' regular meetings in April 2004.
16 September 2004	Written questions regarding previously reviewed notifications of legislation, for consideration at the Committees' regular meetings in October-November 2004.
7 October 2004	Written questions regarding new notifications of legislation to be reviewed at the Committees' regular meetings in October-November 2004.
14 October 2004	Written answers to questions regarding previously reviewed notifications of legislation submitted by 16 September 2004, for consideration at the Committees' regular meetings in October-November 2004.

B. SAFEGUARDS LEGISLATION NOTIFICATIONS

The Secretariat will circulate to Members in mid-September 2004 a list of the **new notifications of legislation** that will be on the agenda for review at the regular meeting in October 2004. Pursuant to procedures adopted by the Safeguards Committee, notifications circulated in all three WTO working languages not later than 13 September 2004 will be reviewed at the Committee's 25 October 2004 regular meeting.

31 May 2004	Written answers to questions regarding new notifications of legislation reviewed at the Committee's regular meeting in April 2004.

11 October 2004	Written answers to questions regarding previously reviewed notifications of legislation submitted by 13 September 2004, for consideration at the Committee's regular meeting in October 2004.
4 October 2004	Written questions regarding new notifications of legislation to be reviewed at the Committee's regular meeting in October 2004.

C. SUBSIDY NOTIFICATIONS

1. 2003 new and full subsidy notifications

2003 new and full subsidy notifications were due no later than **30 June 2003**. Pursuant to the procedures adopted by the Committee at the 8 May 2003 meeting, only notifications circulated in all three WTO languages 19 weeks before a meeting may be reviewed at that meeting. The Secretariat will circulate to Members, shortly after 21 June 2004, a list of the **2003 new and full subsidy notifications** that will be on the agenda for review at the Committee's special meeting scheduled for the week of 1 November 2004.

2. Article 27.4 SCM notifications

At its October 2003 meeting, the Committee agreed to the following dates for the Committee's mandated review of the standstill and transparency commitments relating to the extension of the transition period for certain Members' export subsidy programmes (documents G/SCM/50 - 102 and G/SCM/50/Add.1 – G/SCM/94/Add. 1):
