5.	Title, language and number of pages of the notified document: Proposed Amendment to the Food and Drug Regulations (1333-Thifensulfuron-methyl) (English and French, pages 2967-2969)
6.	Description of content: The Pest Management Regulatory Agency (PMRA), of Health Canada, has recently approved an application to amend the registration of thifensulfuron-methyl in order to allow its use for the control of redroot pigweed, lamb's quarters, velvetleaf, lady's thumb and wild mustard in tomatoes as a post-emergent treatment. This proposed regulatory amendment would establish a Maximum Residue Limit (MRL) for residues of thifensulfuron-methyl resulting from this use in tomatoes, in order to permit the sale of food containing these residues. After the review of all available data, the PMRA has determined that an MRL for thifensulfuron-methyl of 0.07 p.p.m. in tomatoes would not pose an unacceptable health risk to the public.
