TRADE STATISTICS 2001 - AIRCRAFT

CANADA

The following communication, dated 31 May 2002, has been received from the Permanent Mission of Canada.

Attached are two tables of Canadian trade data relating to goods covered by the Agreement on Trade in Civil Aircraft.

Canada's duty free commitment to the Agreement on Trade in Civil Aircraft is implemented under tariff items 9967.00.00 and 9968.00.00¹ and under certain tariff items of Chapter 88 of the Harmonized Systems (HS).

Table A sets out the value of imports, for the year 2001, of goods that were classified under the six-digit Harmonized System (HS) subheadings set out in the Annex to the Agreement (TCA/W/5/Rev.3) and were imported under Canadian Tariff Item 9967.00.00 or 9968.00.00 which has an MFN duty free rate (i.e. non-preferential rate).

Table B sets out the value of imports, for the year 2001, of aircraft and parts thereof of Chapter 88. The trade data for Chapter 88 in Table A is included in the trade data in Table B. Where the Canadian Customs Tariff has distinct provisions for military and non-military aircraft, the import data for military aircraft have been excluded from the data provided.

We would note that the trade data set out in the Tables A and B does not accurately provide the total value of imports to Canada eligible for concessions under the Agreement on Trade in Civil Aircraft for the following reasons:

- many of the goods set out in the Annex to the Agreement on Trade in Civil Aircraft can enter Canada MFN duty free under the regular, non-concessionary, provisions of Canada's Customs Tariff or under preferential trade agreements (e.g. NAFTA). Therefore, in those situations, there is no incentive for importers to use concessionary items 9967.00.00 and 9968.00.00.
- tariff items 9967.00.00 and 9968.00.00 make no distinction between those goods imported thereunder used in civil aircraft and those used for military aircraft.
- the goods classified under Chapter 88 do not always distinguish between military and civil aircraft.
