(a) "General services" Research services Training services Extension and advisory services Inspection services Infrastructural services	<p>Research expenditures funded 12 scientific institutions such as universities, technical institutions, and other institutions involved in primary scientific investigation. Expenditures on training services were for funding an agricultural mechanization school. Expenditures for extension and advisory services consist of funding for an agricultural information center and for a veterinary project for pest and diseases control.</p> <p>Inspection services include expenditures to fund diagnostic veterinary services, diagnostic agricultural services, control services include veterinary, food and seed control, and for chemicals used in agricultural laboratories for food/vet control. Infrastructural services provided funding for water supply facilities (e.g., drainage and pumping station), the restoration of rural infrastructure, restoration of irrigation systems and the small-scale irrigation schemes throughout the country that are provided by the water enterprises. Infrastructural services include environmental protection and conservation measures of the following types: dams for rivers to avoid flooding, to prevent brush fires, soil erosion, and the salination of land, etc.</p>
(b) "Public stockholding for food security purposes"	<p>The GOA has maintained grain reserves. The budget data reflects storage costs, transportation and other marketing costs. The grain reserves maintained by the government of Albania do not affect prices, because the grain is sold by auction and quantities kept under state reserves account for less than one percent of total domestic requirements. Moreover, the quantity kept under state reserves is being reduced as a commitment taken in the framework of the Enhanced Structural Adjustment Facilities (ISAF) program of the IMF.</p>
(c) "domestic food aid"	<p>There are no (and have never been any) programs involving domestic food aid.</p>
(d) "Decoupled income support"	<p>There are no (and have never been any) programs involving decoupled income support.</p>
(e) "Income insurance and income safety-net programs"	<p>There are no (and have never been any) programs involving income insurance and income safety-nets.</p>
(f) "Payments for relief from natural disasters"	<p>This is extraordinary intervention in the form of direct payments to producers for relief from natural disasters (e.g., in times of severe flooding). In 1998, there were no disaster relief payments made.</p>

(i)	"Structural adjustment assistance through resource investment aids"			Structural adjustment assistance through resource investment in agriculture has taken two forms: (1) a land registration program following the land privatization process and (2) the creation of a market for land to facilitate the consolidation of ownership of land and physical holdings (i.e., other immovable assets).
(j)	"Environmental programs"			There are no (and have never been any) direct payments for producers for these types of programs.
(k)	"Regional assistance programs"			There are no (and have never been any) regional assistance programs.
(l)	"Other programs"			Other programs consist of projects associated with central- and district-level administration which provide general services including the commission of land (i.e., involving ownership related matters such as the privatization of agricultural enterprises) and for dispute settlement cases (including cases involving joint venture arrangements with foreigners when there are dispute settlement issues pending). The general services provided for the commission of land are to assist in covering court costs associated with land settlement, land ownership, and privatization issues.
