TRADEMARK OFFICIAL RATES STANDARD

Article 1 This Standard is prescribed in accordance with Article 16-2 of the Trademark Law.

Article 2 The rates payable for applications for trademarks, service marks, collective marks or certification marks, or other relevant applications of the same nature are given below:

1. For a trademark application covering twenty (20) items or less of designated goods, NT\$4,000 per application; for 21 items to 60 items, NT\$6,000 per application; for 61 items or more, NT\$10,000 per application.
2. For an application for a service mark, collective mark, or certification mark, NT\$4,000 per application.
3. For an application to amend the device of a trademark or other mark filed before the approval, NT\$ 4,000 per application.
4. For an application to amend the designated goods of a trademark filed before the approval, NT\$1,500 per application covering twenty (20) items or less of designated goods; NT\$3,500 per application covering twenty-one (21) to sixty (60) items of designated goods; NT\$7,500 per application covering sixty-one (61) items or more of designated goods; an additional NT\$1,500 will be charged for each application if the class of the designated goods is to be amended.
5. For an application to amend the designated services of a service mark filed before the approval, NT\$1,500 per application; an additional NT\$1,500 will be charged for each application if the class of the designated services is to be amended.
6. For an application to amend matters other than those set forth in Items 3, 4 and 5 filed before the approval, NT\$600 per application.
7. For an application to amend the type of a trademark or other mark filed after either the approval or the registration, NT\$2,000 per application.

8. For an application to delete or restrict the designated goods or services of a trademark or other mark filed after either the approval or the registration, NT\$600 per application.
9. For an application to amend matters other than those set forth in Items 7 and 8 filed after either the approval or the registration, NT\$600 per application.
10. For an application to register assignment, NT\$2,000 per application.
11. For an application to register license or sub-license, NT\$2,000 per application.
12. For an application to register pledge, NT\$2,000 per application.
13. For an application to terminate license registration or blot out pledge registration, NT\$1,000 per application.
14. For an application to re-issue a registration certification, NT\$600 per application.
15. For an application to renew the term of the exclusive right to use a mark, NT\$4,000 per application.
16. For an opposition application, NT\$2,500 per application.
17. For an invalidation application, NT\$5,000 per application.
18. For an application to intervene in invalidation proceedings, NT\$1,500 per application.
19. For a cancellation application, NT\$5,000 per application.
20. For an application to issue all kinds of certificates, NT\$600 per application.
21. For an application to review the file records of a case, NT\$600 per application.

Article 3 This Standard shall take effect one month after the promulgation.

Amendment to this Standard of 1 November 2000 shall come into force on 1 January 2001.
