STATUS OF NOTIFICATIONS OF LAWS AND REGULATIONS  
UNDER ARTICLES 18.5 AND 32.6 OF THE AGREEMENTS

Note from the Secretariat

At the third joint special meeting of the Committees to review notifications of laws and regulations under Articles 18.5 and 32.6 of the Agreements, the Secretariat was asked to prepare a document indicating the status of legislations in WTO Members. The following list is prepared by the Secretariat in response to that request.

Pursuant to decisions of the Committees at special meetings on 21 and 22 February 1995, all Members which have legislation and/or regulations regarding anti-dumping or countervailing duty investigations or reviews covered by the Agreements were required to notify the full and integrated text of the relevant legislation and/or regulations to the Committee by 15 March 1995. If such legislation and/or regulations did not exist or were not yet available, the Member would inform the Committee of this fact, and would explain the reasons therefore.

The following lists reflect the status of notifications by all Members of the WTO as of the date of preparation of this document. It is to be noted that certain of these countries and customs territories became Members of the WTO after 1 January 1995, and in some cases quite recently. Further, this document is based the best information available to the Secretariat at this time. The Secretariat welcomes any comments or corrections from Members.
