The following communication, dated 27 June 1995, has been received from the Permanent Mission of Cyprus.

On behalf of the Government of the Republic of Cyprus and pursuant to Article 11.2 of the Agreement on Safeguards, I have the honour to inform you that import restrictions currently maintained by Cyprus on a global basis and which were circulated to WTO Members on 27 March 1995 (G/SG/N/3/CYP) will be eliminated by 31 December 1998.

The list of products subject to import restrictions is herewith resubmitted.
