

(2) The following certificates shall be issued in respect of matters set out in the title to the forms enumerated:

Certificate of Assignment: Form 0.4;

Certificate of Registration of Registered User: Form 0.5;

Certificate of Change of Name: Form 0.6;

Certificate of Extract from Register: Form 0.7,

and the certificates may be amended as directed by the Registrar to meet any contingency.

Authentication of affidavits executed outside the Republic for use within the Republic

59. (1) Any affidavit executed in any place outside the Republic shall be deemed to be sufficiently authenticated for the purposes of use in the Republic if it is duly authenticated at such foreign place by the signature and seal of office of a notary public.

(2) Notwithstanding anything in this regulation contained, the Registrar may accept as sufficiently authenticated any affidavit which is shown to the satisfaction of the Registrar to have been actually signed by the person purporting to have signed such affidavit.

(3) No document required to be filed with the Registrar in terms of these regulations shall be required to be authenticated unless the Registrar specifically otherwise directs in any particular instance.

60. These regulations shall be called the Trade Mark Regulations, 1995, and shall come into operation on 1 May 1995.
