Origin, Geographical Indications and Traditional Specialities
Guaranteed, as well as the Rules for their Use and
Requirements thereof**

According to Part II of Article 37 of the Law of Ukraine “On the Peculiarities of Legal Protection of Geographical Indications for Agricultural Products and Foodstuffs, Protection of Rights and Application of Quality Schemes, including Traditional Specialities Guaranteed for Agricultural Products and Foodstuffs”, Paragraph 8 of the Regulation on the Ministry of Agrarian Policy and Food of Ukraine approved by the Resolution of Cabinet of Ministers of Ukraine No 124 of 17 February 2021, it is stipulated the following:

1. To approve the following documents that are added:

National symbols for agricultural products and foodstuffs with registered names of the place of product origin, geographical indications and traditional specialities guaranteed;

Rules for use of national symbols for agricultural products and foodstuffs with registered names of the place of product origin, geographical indications and traditional specialities guaranteed;

Requirements for national symbols for agricultural products and foodstuffs with registered names of the place of product origin, geographical indications and traditional specialities guaranteed.

2. Department of State Policy in the Field of Sanitary and Phytosanitary Measures should submit this Order to the Ministry of Justice of Ukraine for state registration in accordance with the procedure established by the legislation.

3. This Order shall enter into the force from the date of its official publication.

4. Responsible Deputy Minister should oversee the implementation of this Order.

RULES
for Use of National Symbols for Agricultural Products and
Foodstuffs with Registered Names of the Place of Product
Origin, Geographical Indications
and Traditional Specialities Guaranteed

1. These Rules apply to agricultural products, foodstuffs intended for human consumption, as well as to other related products (hereinafter – agricultural products and food products), specified in Article 2 of the Law of Ukraine “On the Peculiarities of Legal Protection of Geographical Indications for Agricultural Products and Foodstuffs, Protection of Rights and Application of Quality Schemes, including Traditional Specialities Guaranteed for Agricultural Products and Foodstuffs”, and to which legal protection is granted in accordance with this Law.

2. In these Rules, terms are used in the meanings given in the laws of Ukraine “On the Peculiarities of Legal Protection of Geographical Indications for Agricultural Products and Foodstuffs, Protection of Rights and Application of Quality Schemes, including Traditional Specialities Guaranteed for Agricultural Products and Foodstuffs” (hereinafter – the Law) and “On Legal Protection of Geographical Indications”.

3. National symbols for agricultural products and foodstuffs with registered names of the place of product origin, geographical indications, traditional specialities guaranteed (hereinafter – national

symbols) are labelled on foodstuffs, for which the name of the place of product origin, geographical indication and traditional speciality guaranteed are registered in compliance with the requirements for the corresponding quality scheme, provided that such product specification is met.

4. It is forbidden to label national symbols of the quality scheme on agricultural products and foodstuffs, if they do not comply with the respective requirements.

5. It is allowed to label national symbols directly on the packaging, the label (sticker), the necklace of agricultural products and foodstuffs, and, in the absence of packaging, national symbols should be indicated in the document or notice accompanying agricultural products and foodstuffs or referring to them.

6. National symbols can be used in advertisement or media, in the process of elucidating information about registered names of the place of product origin, geographical indications and traditional speciality guaranteed, or giving information about quality schemes in accordance with the Law.
