| 6. | <b>Description of content:</b> In order to prevent the introduction of High Pathogenicity Avian Influenza (HPAI) virus into Japan, MAFF has suspended the import of live poultry, poultry meat and egg products from the department of Ain in France, including those shipped through third countries, since 27 August 2022, based on the "Animal Health Requirements for day-old chicks of poultry to be exported to Japan from France", "Animal Health Requirements for poultry meat etc. to be exported to Japan from France" and Articles 37 and 44 of the "Act on Domestic Animal Infectious Disease Control".  |
