In this regard, since 19 August 2019 temporary restrictions have been introduced on the importation into Kazakhstan from the Khotomel Village of the Stolinsky region of the Brest oblast of Belarus of food-producing animals and free-roaming animals, genetic materials, raw materials and products obtained from animals, horn-hoofed raw materials (horns, antlers, hooves), rawstock (hides of horses, deer and wild animals).
