Description of content: According to the announcement of the Government Gazette dated 2 October 2023, the suspension for the importation or transit of live domestic pig and wild pigs and their carcasses from the Republic of Korea, has expired on 1 January 2024. However, the WOH has reported a continued outbreak of African Swine Fever in the area of the Republic of Korea. Therefore, it is necessary for Thailand to prevent the entry of African Swine Fever disease into the country. By virtue of the Animal Epidemics Act B.E. 2558 (2015), the importation or transit of live domestic pig and wild pigs and their carcasses from the Republic of Korea is temporarily suspended for a period of 90 days after the date of publication in the Thai Royal Gazette.
