Title of the notified document: The DLD order on temporary suspension of the importation or transit of live domestic pigs and wild pigs and their carcasses from Germany to prevent the spread of African Swine Fever. Description of content: According to the announcement of the Government Gazette dated 11 October 2023, the suspension for the importation or transit of live domestic pig and wild pigs and their carcasses from Germany, has expired on 10 January 2024. However, the WOA has reported a continued outbreak of African Swine Fever in the area of Germany. Therefore, it is necessary for Thailand to prevent the entry of African Swine Fever disease into the country. By virtue of the Animal Epidemics Act B.E. 2558 (2015), the importation or transit of live domestic pig and wild pigs and their carcasses from Germany is temporarily suspended for a period of 90 days after date of publication in the Thai Royal Gazette.
