Description: Ministry of Agriculture, Livestock and Food Supply – MAPA, issued Ordinance No. 123, 13 May 2021 (Instrução Normativa Nº 123, de 13 de maio de 2021), in order to complement the identity and quality standards requirements for non-alcoholic beverages such as refreshment, soft drink, composed drink tea and soda and when appropriate, the respective solid and liquid preparations, in the form of this Ordinance and its Annexes.
