Description: The proposed Regulations notified in G/TBT/N/CAN/543 (dated 13 February 2018) were adopted and published on July 20, 2022 as the *Regulations Amending Certain Regulations Made Under the Food and Drugs Act (Nutrition Symbols, Other Labelling Provisions, Partially Hydrogenated Oils and Vitamin D)*. An addendum previously notified in G/TBT/N/CAN/543/Add.1 permitted the voluntary increase of vitamin D in cow's milk, goat's milk and margarine.

These Regulations come into force on July 20, 2022, the day on which they are published in *Canada Gazette*, Part II. Industry will be given a transition period, until December 31, 2025, to comply with the provisions of these regulations, with the exception of the provisions related to partially hydrogenated oils, for which there is no transition period.
