<b>6. Description of content:</b> Inmetro Ordinance No. 210 establishes the nominal content of chewing gum, caramels, confectionery, candy in tablets, chocolate, drops and lozenges.

Objective and rationale, including the nature of urgent problems where applicable:</b> Decree 10.139 of 28 November 2019 provides for the need for revision and consolidation of normative acts below the decree. It aims to update and consolidate regulatory acts, elimination of obsolete regulations whose effects have been exhausted in time or the need cannot be identified. Thus, the inventories and complexity of regulatory processes will be reduced; Consumer information, labelling
