6. Description of content: This Communique shall apply to local space heaters with a nominal heat output of 50 kW or less. This Communique shall not apply to: <ul style="list-style-type: none">• electric local space heaters;• local space heaters using a vapour compression cycle or sorption cycle for the generation of heat driven by electric compressors or fuel;• solid fuel local space heaters that are specified for the combustion of non-woody biomass only;• local space heaters specified for purposes other than indoor space heating to reach and maintain a certain thermal comfort of human beings by means of heat convection or heat radiation;• local space heaters that are specified for outdoor use only;

<ul style="list-style-type: none"> • local space heaters of which the direct heat output is less than 6 % of the combined direct and indirect heat output at nominal heat output; • solid fuel local space heaters that are not factory assembled, or are not provided as prefabricated components or parts by a single manufacturer which are to be assembled on site; • luminous local space heaters and tube local space heaters; • air heating products; • sauna stoves.

Objective and rationale, including the nature of urgent problems where applicable: The objective of this Communique is to lay down the requirements for the energy labelling of, and the provision of supplementary product information on local space heaters with a nominal heat output of 50 kW or less; Harmonization</p>
<p>8. Relevant documents: This Communique has been prepared based on the indication by labelling and standard product information of the consumption of energy and other resources by energy-related products Directive 2010/30/EU of The European Parliament and of The Council and amended by the Commission Regulation EU/2017/2254, Commission Regulation (EU) 2015/1186 with regard to the energy labelling of local space heaters.</p> <p>This Communique has been prepared based on 05/03/2020 dated the Law No. 7223 on the Product Safety and Technical Regulations and on 01/03/2021 dated and 3584 numbered and put into effect by the decision of the Presidency, Regulation on a framework for Energy Labeling.</p>
<p>9. Proposed date of adoption: This Communique will be adopted upon its publication.</p> <p>Proposed date of entry into force: This Communique shall enter into force on the date of publication.</p>
<p>10. Final date for comments: 10 December 2021; The relevant legislation will be put into effect within the scope of harmonization with the EU legislation.</p>
