6. Description of content: This Communiqué shall apply to solid fuel local space heaters with a nominal heat output of 50 kW or less. This Communiqué shall not apply to: <ul style="list-style-type: none">• solid fuel local space heaters that are specified for the combustion of non-woody biomass only,• solid fuel local space heaters that are specified for outdoor use only,• solid fuel local space heaters of which the direct heat output is less than 6 % of the combined direct and indirect heat output at nominal heat output,• solid fuel local space heaters that are not factory assembled, or are not provided as prefabricated components or parts by a single manufacturer which are to be assembled on site,• air heating products,• sauna stoves.

Objective and rationale, including the nature of urgent problems where applicable: The objective of this Communique is to lay down the ecodesign requirements for the placing on the market and putting into service of solid fuel local space heaters with a nominal heat output of 50 kW or less; Harmonization
8.	<p>Relevant documents: This Communique has been prepared based on the Regulation on a framework for the setting of Ecodesign Requirements For Energy-Related Products 2009/125/EC and amended by the Commission Regulation EU/2016/2282, Commission Regulation (EU) 2015/1185 with regard to ecodesign requirements for solid fuel local space heaters.</p> <p>This Communique has been prepared based on 05/03/2020 dated the Law No. 7223 on the Product Safety and Technical Regulations and on 23/06/2010 dated and 2010/643 numbered and put into effect by the decision of the Council of Ministers, Regulation on a framework for the setting of Ecodesign Requirements For Energy-Related Products.</p>
