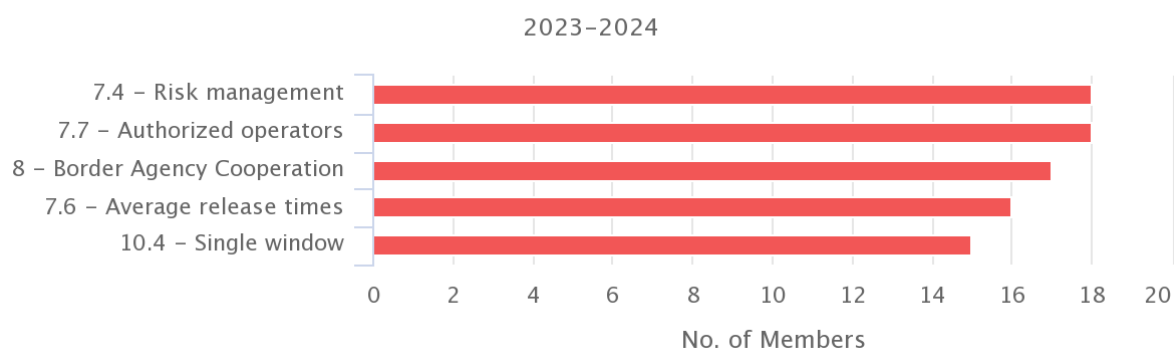
**TRADE FACILITATION AGREEMENT'S DEFINITIVE IMPLEMENTATION DATES

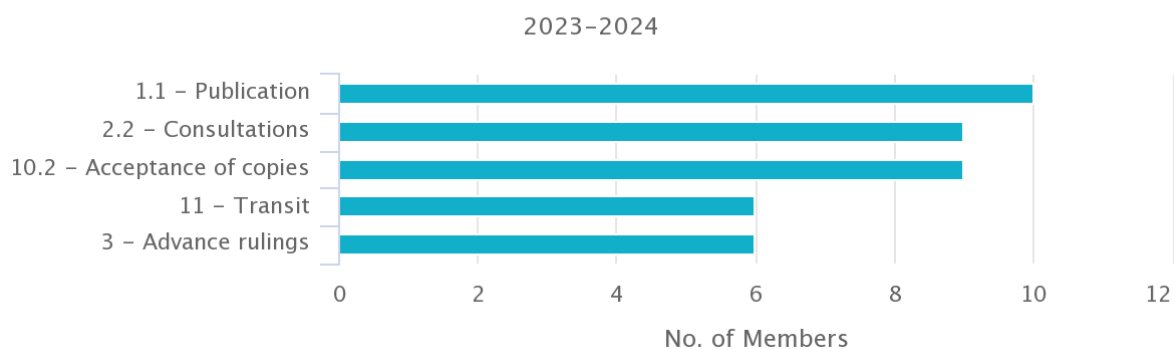
53 Members have committed to implement 268 Category C measures in 2023-2024
