REGIONAL TRADE AGREEMENTS SUBJECT TO IMPLEMENTATION REPORTS

UPDATED AS OF 8 FEBRUARY 2021

This document lists regional trade agreements (RTAs) notified under Article XXIV of the GATT 1994 and GATS Article V for which an implementation report is due, in accordance with paragraph 15 of the Transparency Mechanism for RTAs.¹

As of 8 February 2021, implementation reports are due for 156 RTAs, and the end of implementation (EOI) for 17 RTAs is in 2021. The EOI for a total of 132 RTAs is from 2022 onwards, while for 1 RTA the EOI year is not available.^{2, 3}
